Buyer's Premium: Buyer's premium is 10% of the total selling price.

Amount is due at time of bid acceptance. Buyers will be required to sign a North Carolina "OFFER TO PURCHASE AND CONTRACT" in addition to all standard forms at the time of bid acceptance.

Deposit on Real Estate: A deposit of 10% of the high bid amount is required. All bidders must provide proof of funds to close within 30 days. Deposit is to be by cashier's check or pre-approved check, made payable to SWIFT AUCTION SALES, INC. Personal checks must be accompanied by proof of funds available on the day of sale from the bank on which the check is drawn.
